NOTICE OF ELECTION - TOWN OF CENTURY

*Pending approval of the Century Town Council on Sunday, February 9, 2025

A Special Election for Mayor and Town Council Seat 4 will be held as follows:

PRIMARY ELECTION – Tuesday, March 18, 2025

(only if contests have three or more candidates)

GENERAL ELECTION – Tuesday, April 29, 2025

Candidates who wish to run for Mayor must meet the following qualifications (Section 4.02 Town of Century Charter, Ordinance 05-14)

- Registered voter in the Town of Century (Precinct 22.1)
- Registered to vote and residing in the town for at least six (6) months prior to qualifying
- Pay a \$126.32 qualifying fee

Candidates who wish to run for Town Council Seat 4 must meet the following qualification (Section 3.02 Town of Century Charter, Ordinance 05-14)

- Registered voter in the Town of Century (Precinct 22.1)
- Pay a \$50.00 qualifying fee.

The qualifying period will begin at 9:00 a.m. Monday, February 10, and run through Wednesday, February 12, at noon. On Monday, February 10, from 9:00 a.m. to 3:00 p.m. candidates may have assistance with their qualifying paperwork at the Century Town Hall. The remainder of the qualifying period will be held at the Escambia County Supervisor of Elections Office, 213 Palafox Place, Second Floor, Pensacola, FL 32502.

To be eligible to vote in the Century Elections, you must be a registered voter and a resident of the Town of Century. Registration for the Primary Election closes on Monday, February 17, 2025; registration for the General Election will close on Monday, March 31, 2025.

If you wish to receive a vote-by-mail ballot for the Town of Century Primary and/or General Election, you must contact the Supervisor of Elections office by phone (850) 595-3900, by e-mail at votebymail@escambiavotes.gov, by fax (850) 595-3914, or by using the online form at EscambiaVotes.gov/vote-by-mail. Requests must be received by 5:00 p.m. 12 days before the scheduled election.

Polls will be open on Election Day from 7 a.m. until 7 p.m. at the Billy G. Ward Century Courthouse, located at 7500 North Century Boulevard, Century.

Any voter wishing to *update their address* can call us at (850) 595-3900. We can take your information over the phone or e-mail us at <u>soe@escambiavotes.com</u>, please include name, date of birth, and the last four digits of your Social Security number or your Driver's license number in your message. A Florida Voter Registration Application may also be completed.

A *change of name*, *party affiliation*, *and/or signature update* can be made on a completed Florida Voter Registration Application. The Century Elections are a nonpartisan election.
